The U.S. Army Corps of Engineers has just released its plan to spend the \$17.1 billion Congress provided last November when it passed the Administration's Infrastructure Investment and Jobs Act. That bill required the Corps to produce a Work Plan detailing how it wants to spend the money in 60 days. - SAN DIEGO COUNTY SHORELINE (ENCINITAS-SOLANA), CA Complete initial sand placement on Encinitas and Solana beaches. \$30,542,000
- PINELLAS COUNTY, FL (Long Key) Complete renourishment of the Long Key segment. \$7,913,000
- PINELLAS COUNTY, FL (Treasure Island) Complete renourishment of the Treasure Island segment. \$9,222,000
- MANASQUAN INLET TO BARNEGAT INLET, NJ. Complete renourishment of the beach and monitoring activities. \$30,200,000
- RARITAN BAY AND SANDY HOOK BAY, HIGHLANDS, NJ. Initiate, physically complete and fiscally close out project. \$128,700,000
- SANDY HOOK TO BARNEGAT INLET, SEA BRIGHT TO NJ. Complete renourishment of the beach and monitoring activities. \$24,400,000

- SOUTH SAN FRANCISCO BAY SHORELINE, CA (PALO ALTO). Initiate and complete feasibility study phase

- PLANNING ASSISTANCE TO STATES. Provide planning and technical assistance to States and local communities for a wide variety of water resource efforts. \$30,000,000

Disaster Relief Supplemental Appropriations Act

Signed into law last September, the Disaster Relief Supplemental Appropriations Act provides the Corps with funding for emergency relief from Hurricane Ida and other previous disasters.

- NEW ORLEANS TO VENICE, LA (HURRICANE PROTECTION) - Complete authorized work on the east and west banks of Plaquemines Parish by replacing or modifying the flood and storm damage risk reduction levee infrastructure to the 50-year Level or Risk Reduction (LORR). \$783,000,000
- RESILIENCY ASSESMENT - WEST SHORE, LAKE PONTCHARTRAIN, LA - Complete authorized work on the east and west banks of Plaquemines Parish by replacing or modifying the flood and storm damage risk reduction levee infrastructure to the 50-year Level or Risk Reduction (LORR). \$450,000,000
- ALASKA COASTAL EROSION, AK – BARROW Complete all pre-construction, engineering and design (PED) and construction of the Barrow segment of this program. \$364,290,000
- FAIRFIELD AND NEW HAVEN COUNTIES (FLOODING), CT--downtown New Haven, CT. Construct and complete floodwall, closures, and pump station to protect the Long Wharf area of downtown New Haven, CT. \$160,249,000
